### **Minutes**

### 1 Welcome and Acknowledgment of Country

CM acknowledged country.

SS and CM provided a brief introduction of ReCFIT and each presenter's role, before asking each member to provide their name and short brief of why they were interested in attending the SRG program.

Broadly, the reasons the SRG members joined were:

- wanting to learn about where transmission lines are going and why
- understanding and providing input on cultural & heritage factors
- interest in environmental impacts from REZ and new infrastructure, and
- what are the benefits and how will they be shared?

CM briefly provided some expectations around conduct for the group, including:

- active participation and collaboration being encouraged
- all ideas, discussion and contributions being welcomed, in a kind, open-minded, positive and respectful manner.

CM introduced an ice breaker activity by asking the following questions to the group:

- Where do you think you/your community is at on their REZ journey?
- What are you hearing in your community?

Discussion and written contributions from the group, when answering the questions, displayed a neutral sentiment overall. Some key insights from members were:

- there is limited or mixed understanding and awareness about REZ
- the limited understanding is attributed to REZ being new (to Tasmanians). This is positive as engagement is early
- concerns around environment, natural value impacts of transmission lines, scepticism toward the benefits, and negative views towards projects and proposals before full understanding
- the idea of a REZ sounds good, and
- there is great optimism towards a switch to electrification.

#### 2 Government's Renewables Agenda Overview

SS described the benefits to the state of increasing renewable energy capacity:

• Tasmania currently leads the way - 100% net renewable generation

3	Renewable Energy Zones overview
	<ul> <li>When discussing "Why more renewables?" the group had a common misconception that we are in an energy surplus.</li> </ul>
	<ul> <li>Stewart explained that we are in Energy Balance. Whether it is on- island growth, electrification, the growth of a green industry or export of clean energy to help the rest of Australia decarbonise, we will need more energy.</li> </ul>
	Group sentiment was positive towards understanding the "why" which was previously an uncertain point for group members.
4	What is REZ?
	The group began an exercise by discussing and recording some different views on potential benefits, challenges, risks and impacts of a future REZ.
	Some common themes around benefits began to form around:  • jobs
	<ul><li>education, training, and jobs for young people</li><li>cheaper energy</li></ul>
	<ul> <li>certainty for investors, and</li> </ul>
	infrastructure improvements.
	Common challenges brought forward by the group consisted of:
	<ul> <li>delays in planning processes and the current planning system not being fit for purpose</li> </ul>
	gaining community trust
	education and training arrangements
	shifts in costs and policy positions

Stewart described the work over the nine months to December 2023 and why the North west region was announced as the first to focus on:

- provides for the largest potential transfer capacity,
- the lower cost per MW of new transmission capacity augmentation
- high levels of existing commercial interest due to proximity to marinus and high quality wind resources, and pumped hydro potential etc.
- concessional finance announced by the Commonwealth for the North West Transmission Development - suppresses cost impacts on Tasmanian customers.

#### What the next steps look like:

- a range of technical studies relating to transmission and design of the offering for proponents who may wish to locate in the REZ (costs and other features like access, connection processes)
- a dedicated community engagement program which aims at educating and providing opportunities for community to participate, including SRG-establishment and in-region targeted sessions, pop-ups, forums etc.

### 7 North west Stakeholder Reference Group

CM provided an overview of the SRG's role, that is:

- to inform and guide REZ processes, ensuring lasting local community benefits
- encouraging a cooperative and regionally consistent approach
- council and community representation
- continued and open collaboration with your community

Members of the SRG were asked, what does success for the SRG look like? Answering this question opened discussion, which captured the following:

- keeping the community informed in plain English
- clearly explaining how to generate new power, connecting to existing infrastructure with the least amount of environmental damage
- explaining that REZ establishment is not a project proposal (e.g. this
  is not a wind farm proposal), rather REZ is simply a great area for
  any renewable project to be situated
- what if proponents spend more to upgrade existing infrastructure instead of cutting through new transmission lines?
- SRG success would ensure deeper connection with community and provide legacy for existing projects.
