In recognition of the rich diversity of Tasmania's Aboriginal cultures and communities, we intend to undergo further cultural training with other Tasmanian Aboriginal groups. We are grateful to MTWA Corp, particularly Jo and Aunty Patsy, for generously sharing their time and knowledge with us.
